




Organizational Structure

Recommendations to the Government for "Japanese Export Control Reform"

- Streamlining Transaction and Reducing Burden
 - ✓ Simplifying the Structure of the Export Control Legislation
 - ✓ Reducing the Burden for Exporters
 - ✓ Easing the Export Paperwork Burden
 - ✓ Reviewing Controls with Regard to the Foreign Availability Point
 - ✓ Reviewing Controls which are Not Internationally Harmonized
 - ✓ Changing the Export Control Numbering Structure to the "EU Standard"

In October 2010, the Export Control Research Committee Submitted the "Proposal" for Reviewing the Structure of the Existing Japanese Export Control Legislation to the Ministry of Economy, Trade and Industry (METI) And more Comprehensive "Proposal" will be Submitted to METI in February 2012 as well.
