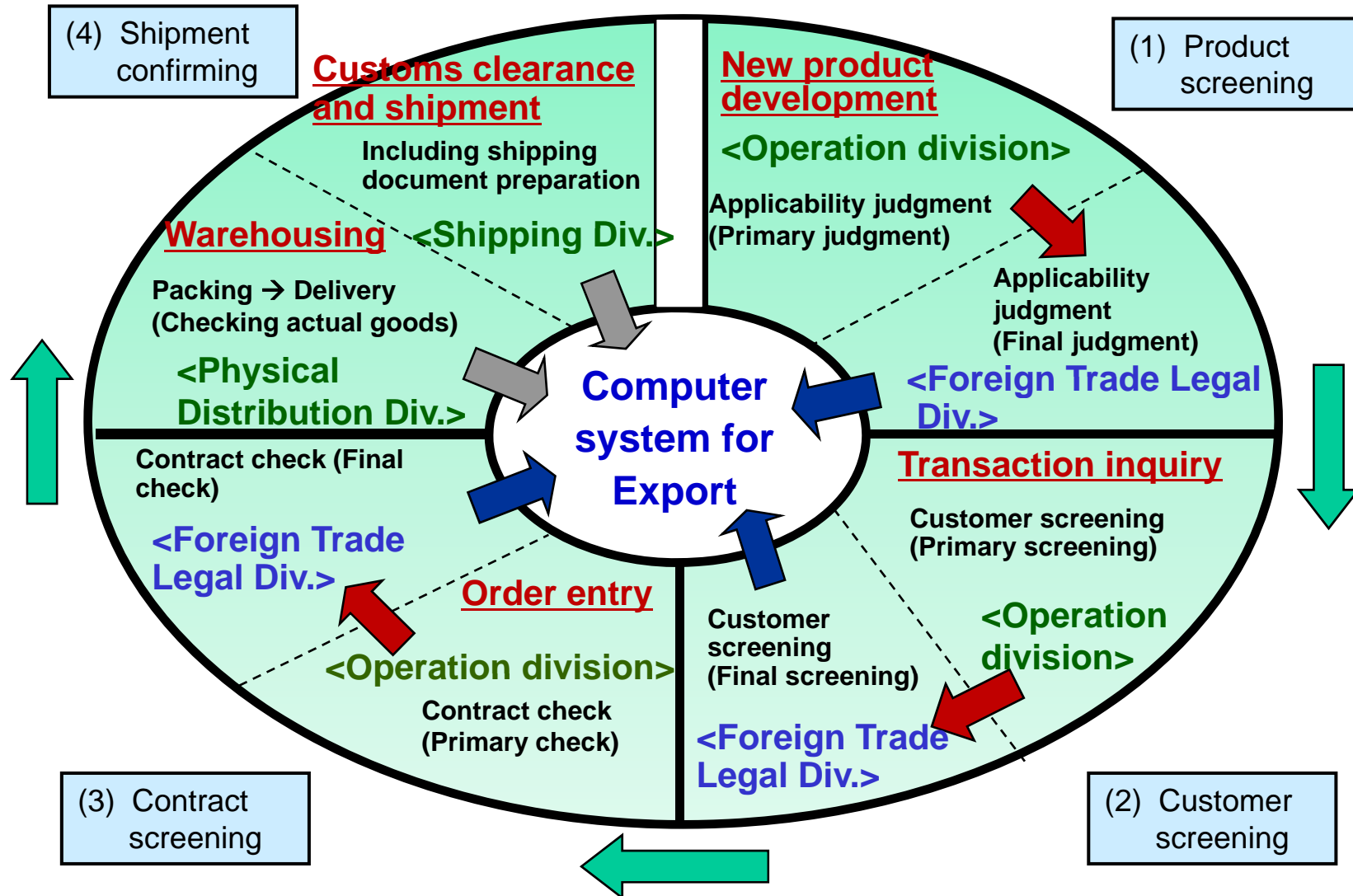
Canon's STC Compliance Organization



Roles of Foreign Trade Control Div.

1. Establish internal control organization
2. Set up control rules, procedures and their manuals
3. Screen products and technology (final responsibility)
4. Screen customer and transaction (final responsibility)
5. Judge and obtain necessary E/L
6. Educate employee
7. Support Corporate Audit Center
8. Support affiliates

Export control procedure in Canon



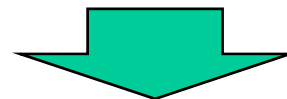
STC Compliance Program

Compliance Program (CP)

- CP on the Security Trade Control under Japanese Foreign Exchange & Foreign Trade Law

The CP consists of basic company policy, compliance organization, role & responsibility, control procedure, audit and penalty.

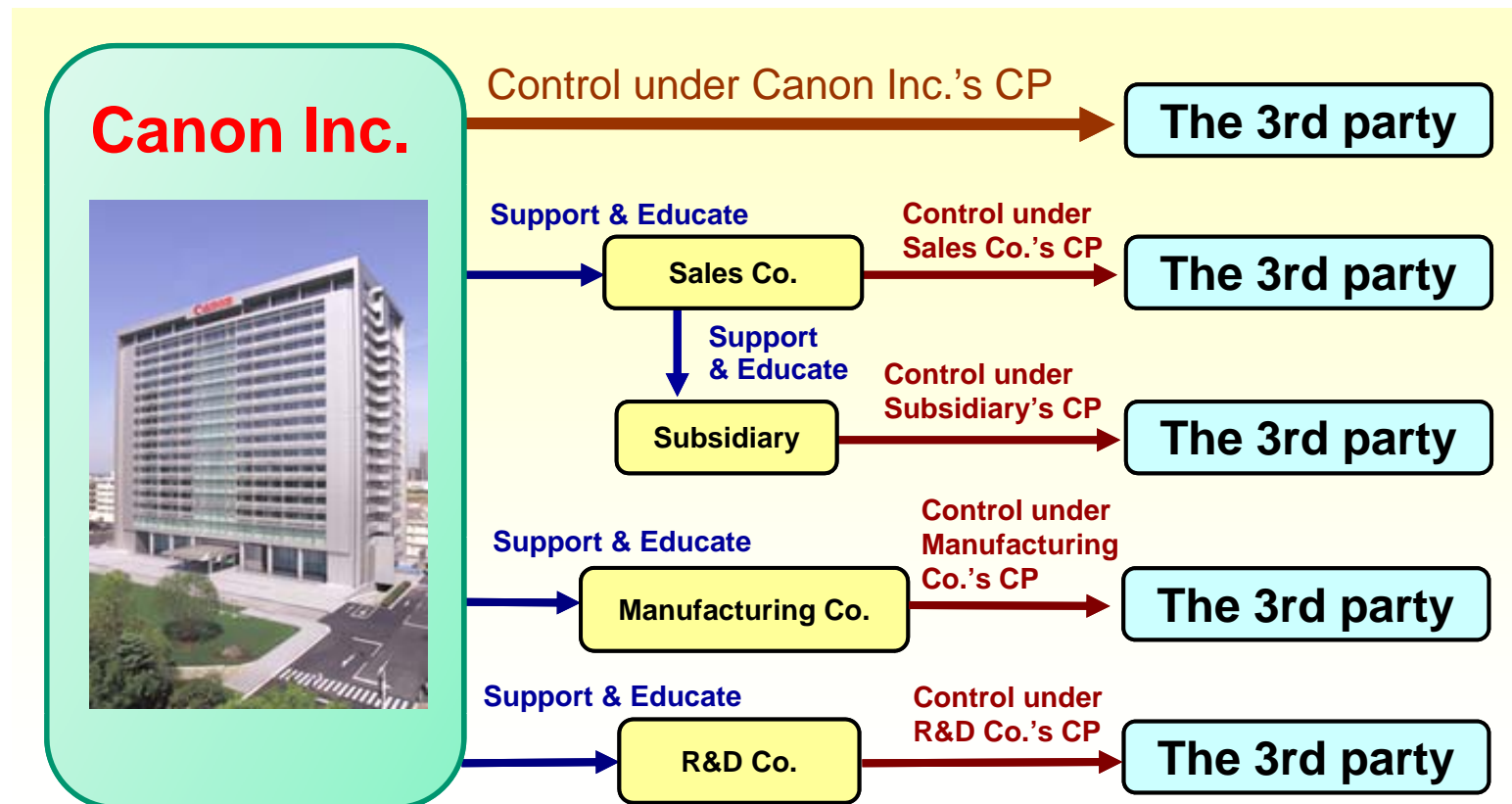

Responsibility on STC in Canon Group

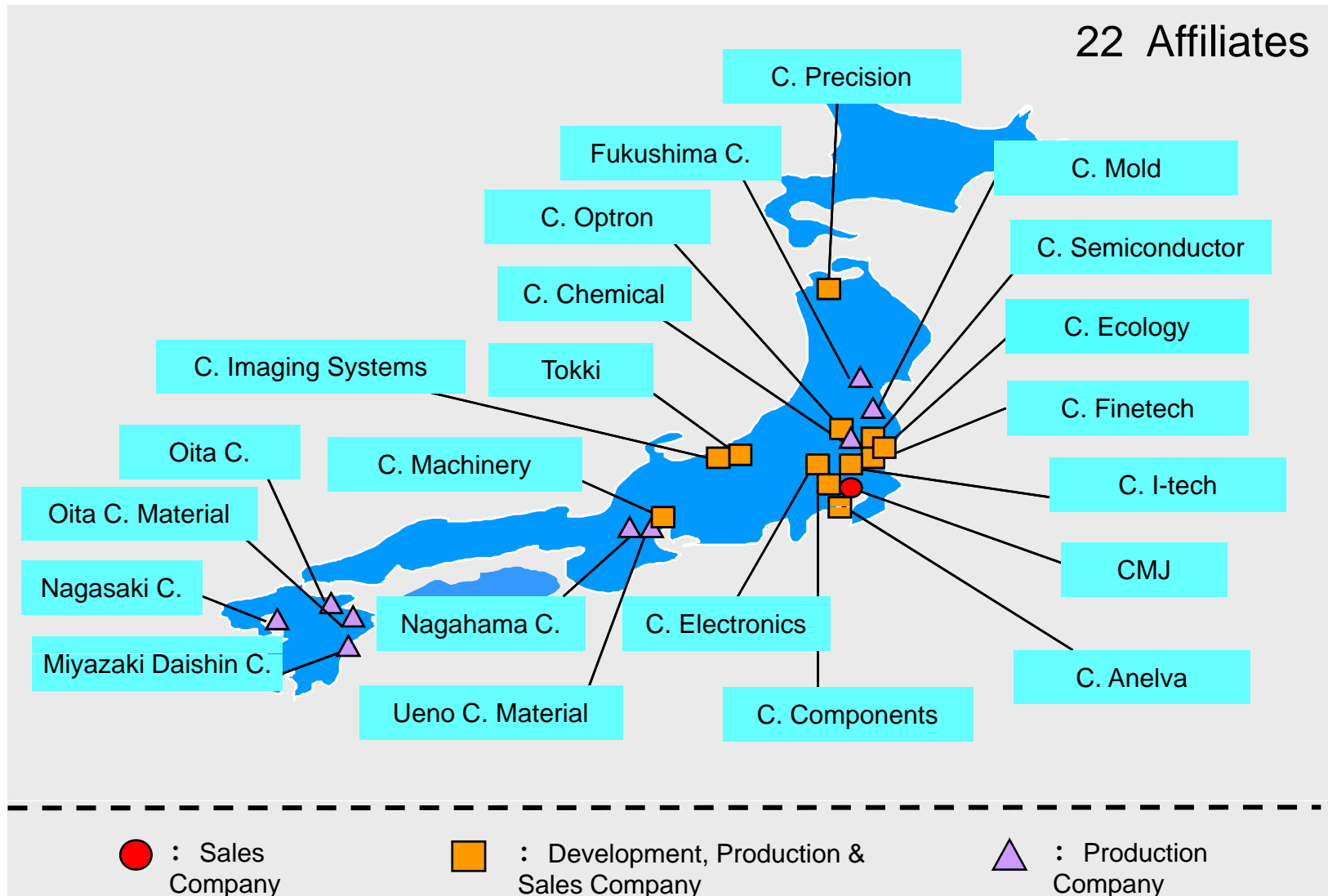
1. Parent companies have to support and supervise their subsidiaries.
2. Companies who deal with 3rd parties are responsible for STC compliance.
3. Canon has all responsibility of technical data for Canon's goods & technologies.



Domestic Affiliates that have STC organization

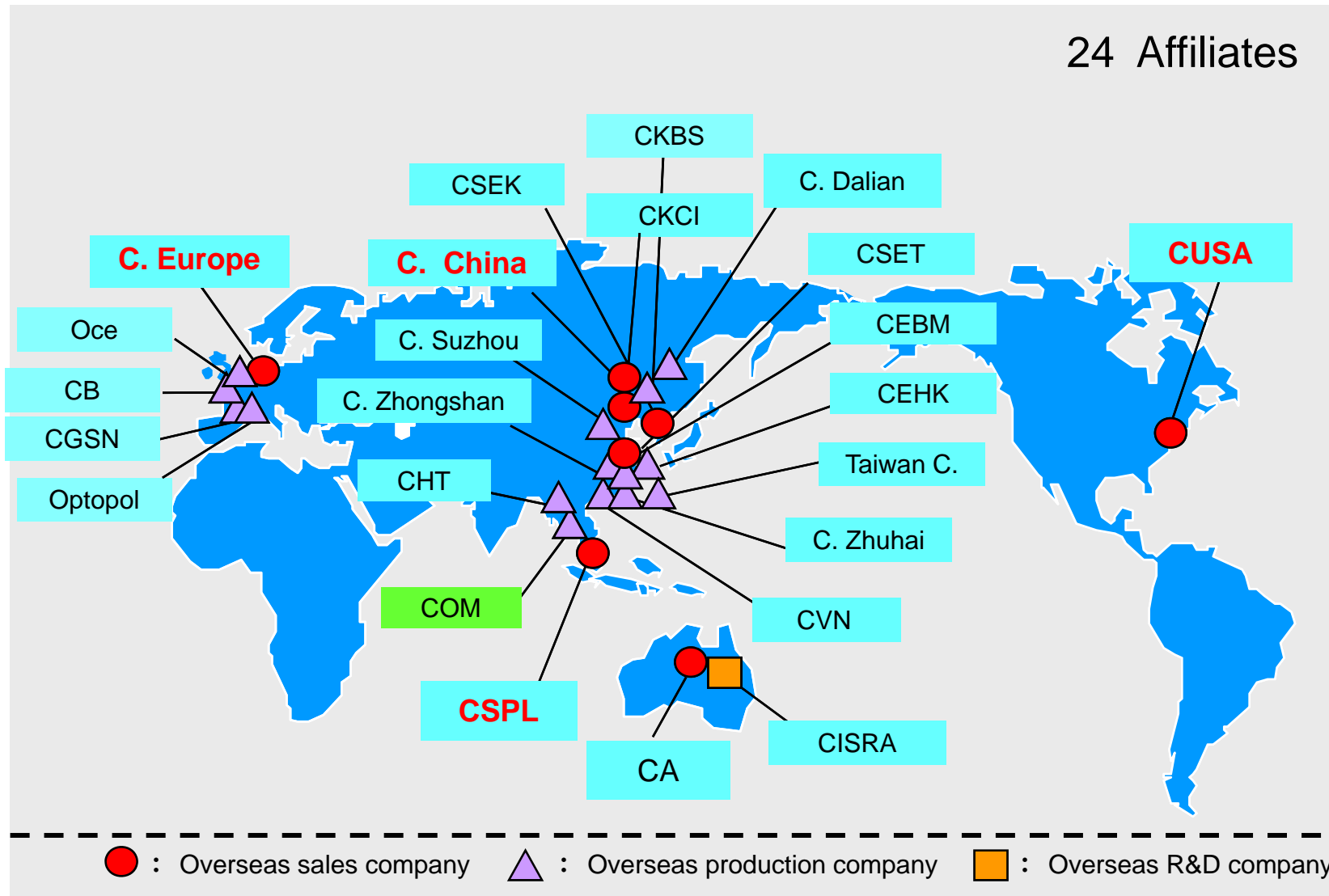

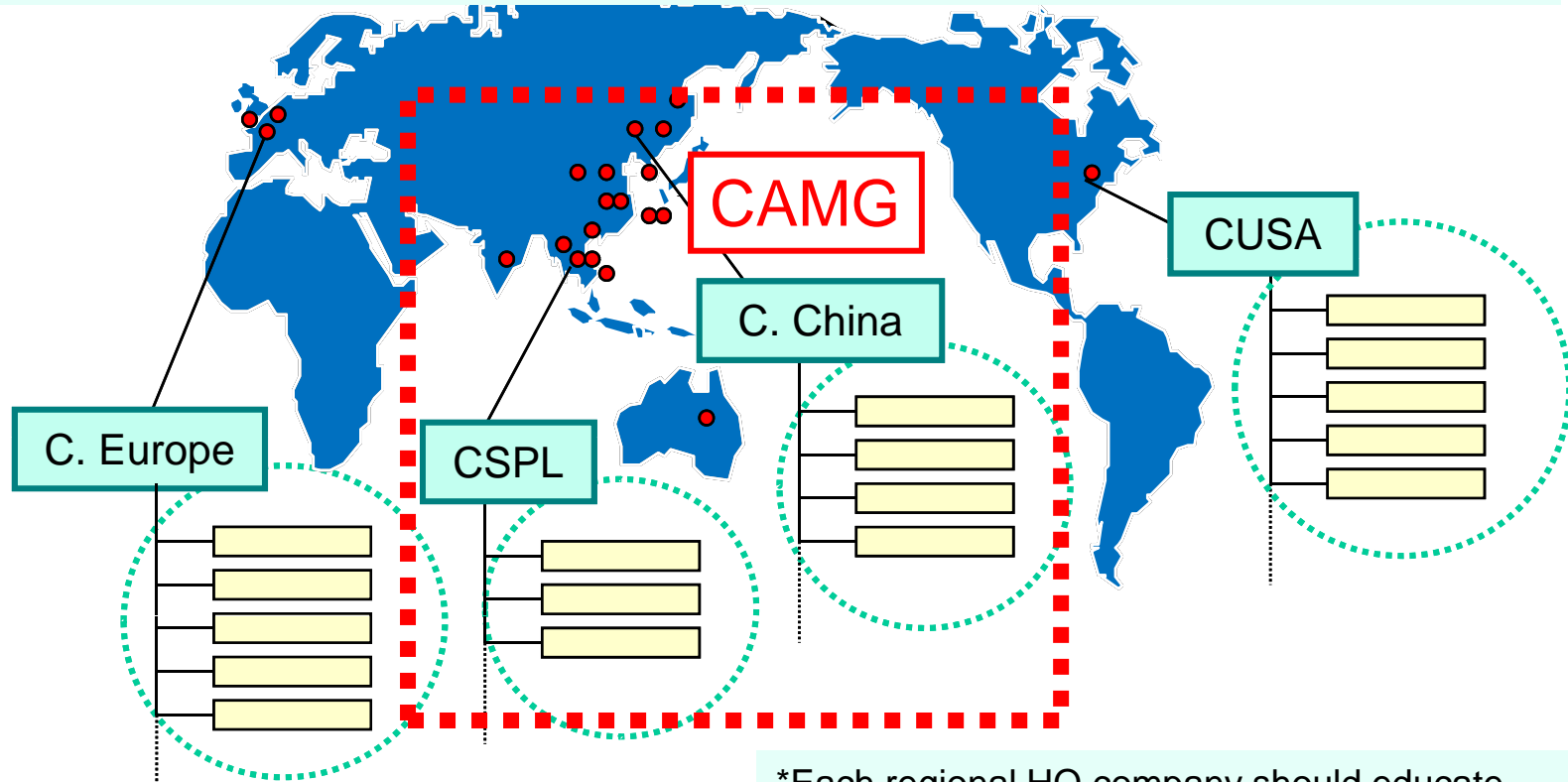
Overseas Affiliates that have STC organization

Roles of regional HQ companies

It will be more and more important that not only Canon's direct subsidiaries but also the whole group companies adhere to Security Trade Control related laws, regulations and Canon's policies.

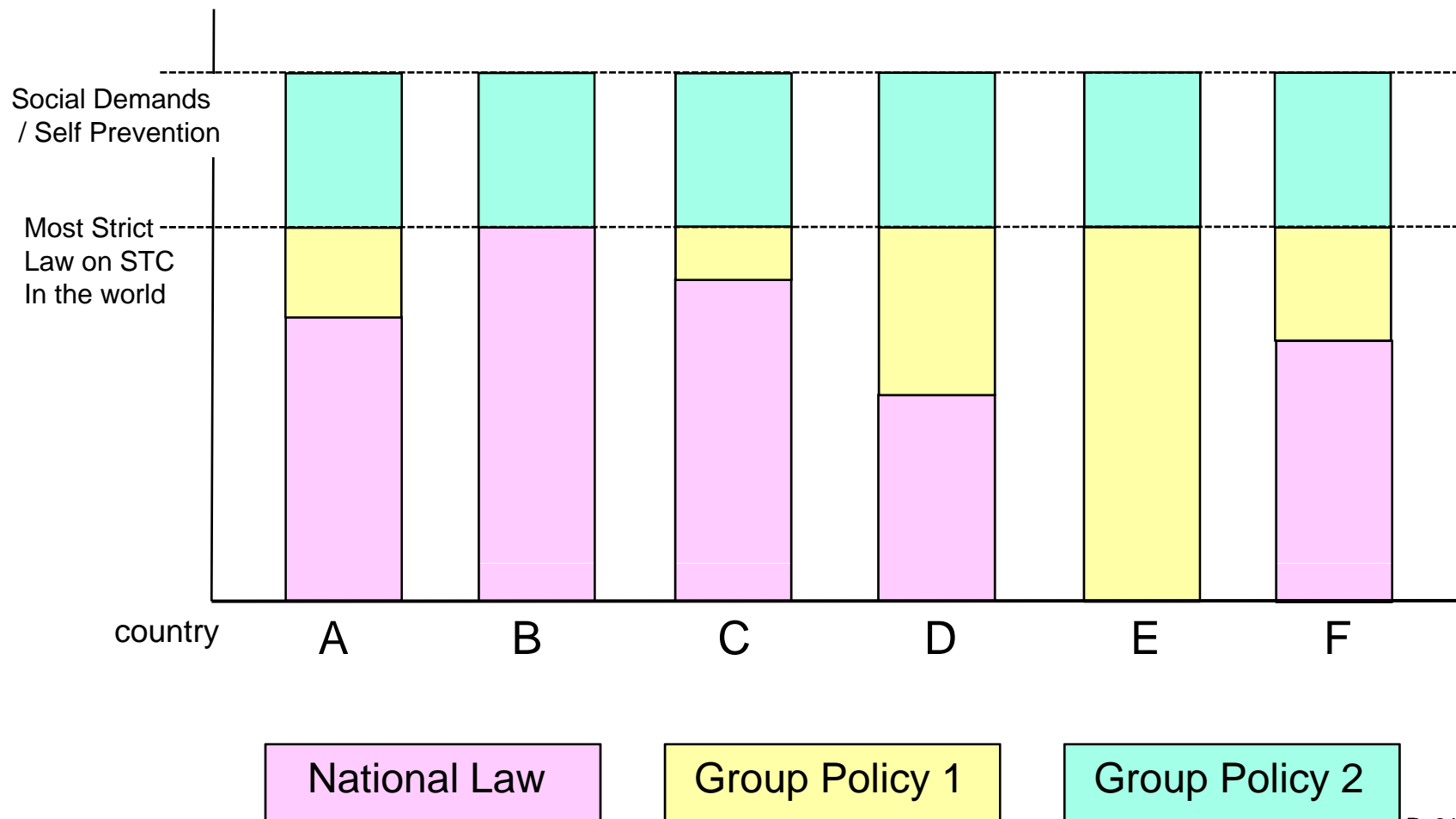

Principles of STC in Canon Group

Group Standard for STC compliance

- *The president takes a position as the highest responsible officer for Security Trade Control (STC).
- *A division which is independent of sales division, takes a position as the overall control division on STC.
- *Clarifying the necessary control process and procedures on STC.
- *Setting up the proper administrative structure on STC based on the type & scale of the business of the company.
- *Conducting internal audits on STC.
- *Setting up a **C**ompliance **P**rogram on STC and keeping it effective.
