Recent Developments In Asia Export Controls (1)

- **Asia-Pacific**
 - Australia: incorporates comprehensive brokering controls into system
 - Malaysia: commences Customs verification of export permits
 - Philippines: working on strategic trade control bill
 - Singapore: announces Advance Export Declaration (AED), to be become effective April 1, 2013
 - Taiwan: issues new internal compliance program (ICP) guidance and implications

Recent Developments In Asia Export Controls (2)

- **Eurasia**
 - Azerbaijan: introduces new *lcazeler* electronic permit system and new Customs Code with strengthened strategic trade enforcement provisions
 - Kazakhstan: publishes draft resolution on end-user certificates and verification
 - Russia: institutes more rigorous ICP auditing and certification procedures, and government outreach obligations
- **Southwest Asia**
 - Several countries working to introduce or enhance strategic trade control legislation

Asia-Pacific Export Control Landscape

- **10 countries and areas in Asia-Pacific (out of 24)* currently have dual-use export control systems; of those:**
 - All with some form of controls on transits and/or transshipments (most with exceptions and/or end-use-based)
 - 7 with controls on intangible transfers of technology (ITT) (at least 3 with some form of “deemed” export control)
 - 6 with controls on brokering dual-use items (3 end-use-based only)
 - 4 with special destination/diversion-risk control list-based licensing

** Using one of several definitions of who and how many constitute “Asia-Pacific”*

Issues For Consideration In Asia Export Controls

- **Differences in inter-regional export control systems and approaches and their potential impact on regional trade**
- **Multi-lateral export control regime adherence**
- **“Silk Road” and similar regional connectivity initiatives and their implications**
- **Extent of regional cooperation and coordination in the area of strategic trade enforcement**

Issues For Consideration In Asia-Pacific Export Controls

- **Countries/areas at different stages of export control development**
- **Countries/areas with different control lists and item coding systems**
- **Implementation of “full-scope” export controls in the areas of brokering, transit/transshipment, and ITT control**
- **Export controls and free trade/special economic zones**
- **Incorporation of export controls into regional/sub-regional “Single Window” systems**

- Korea, Ministry of Knowledge Economy (MKE) “Catch-All” List

Asia-Pacific Examples (And Resources) (2)

- **Taiwan's Bureau of Foreign Trade (BOFT) "Red Flags"**
 1. Overseas traders who are named on the international export control list or those named specifically by the competent authorities.
 2. Overseas traders or agents who are not willing to provide the end-use or end-users of the commodities, or traders with virtually no business background.
 3. Product functions and specifications are not consistent with business demands of overseas traders or technological standards of the importing countries.
 4. Selling prices, trade terms or payments that are not consistent with international trade norms.
 5. Overseas traders who are not familiar with product functions, but insist on buying the said commodities, or overseas traders who refuse routine installation, training or follow-up maintenance services.
 6. Without justification the dates of transportation and destination are uncertain, the end-consignee for the forwarder or the consignee and place have been suddenly changed.
 7. Without justification the packing methods, shipping routes or labels of commodities are suspicious.

Considerations
In 2005, the WMD Study Group formed an Export Controls Experts Group (XCXG) to assess national export control programs, identify vulnerabilities and shortcomings, and develop recommendations for improving both individual export control capacity and mutual cooperation.

Increasing energy demand in the Asia Pacific region, combined with the perceived need for energy security or self-sufficiency, has led many countries to develop or to at least contemplate the use of nuclear energy.

Previously US CSCAP also created a Nuclear Energy Experts Group (NEEG) to promote nuclear energy transparency, in part through the creation of an Asia Pacific Nuclear Energy Transparency web site www.cscap.nucltrans.org.

Specific agenda
This Experts Group analyses current efforts and practices of national-level export controls of nuclear energy, and explores additional ways to promote and enhance nuclear energy transparency. The work of this Experts Group is very much congruent with and complementary to its parent group, the CSCAP Study Group on Countering the Proliferation of Weapons of Mass Destruction.

Summary Observations

- **Several important developments and signs of continued progress in Asia (and Asia-Pacific) export controls**
- **Until more countries institute some form of export controls, export control “inequality gap” in the region may continue to widen, as may its implications**
- **Among countries and areas with export control systems, even greater intra- and inter-regional parity in terms of control lists and types worth considering**
- **Many solid examples of “best practices” in the region that could serve as models (or even resources) for others**
- **Maximizing existing regional/sub-regional institutions and strengthening (or creating) new ones → from ASEAN to the CSCAP XCXG to formal expert networks**
