# TIMELINE OF SELECTED UN SECURITY COUNCIL RESOLUTIONS (UN SCR)

# Timeline of selected UNSCR (1)

July 2006

DPRK launches a ballistic missile

#### **UN SCR 1695**

- » Demanded the suspension of all ballistic missilerelated activities
- » Requires all member states to prevent trade with DPRK in missile technology

Oct. 2006

DPRK conducts its first nuclear test

#### **UN SCR 1718**

- Demanded the suspension of all ballistic missilerelated activities
- Imposed a sanctions regime on DPRK
- » Established a Sanctions Committee to oversee the implementation of the sanctions

# Timeline of selected UNSCR (2)

May 2009 June 2009 DPRK conducts its second nuclear test

**UN SCR 1874** 

- » Strengthened sanctions regime, including broader financial sanctions
- » Created a Panel of Experts

**April 2012** 

DPRK satellite launch

#### **UN SC Presidential Statement 2012/13**

- Strongly condemned the satellite launch by DPRK
- Demanded that DPRK stop all nuclear tests and ballistic missile activity
- Directed the Sanctions committee to designate additional entities and items to be subjected to sanctions.

## Timeline of selected UNSCR (3)


December 2012 DPRK satellite launch

January 2013 UNSCR 2087 (2013)

- » Strengthened sanctions regime, including broader financial sanctions and
- » Designated additional individuals, entities and items to be subjected to sanctions.
- » Clarifies some of the measures stated in resolutions 1718 (2006) and 1874 (2009)
- » Expresses its determination to take significant action in the event of a further DPRK launch or nuclear test.

February 2013 DPRK conducts its third nuclear test

# Goods designation procedure


Security Council or 1718 Sanctions Committee

- individuals and entities subject to travel ban and asset freeze



#### Goods-related sanctions

#### **Are prohibited:**

- Buying from or selling to DPRK all arms and related materiel (except supply of small arms and light weapons)
- Buying from or selling to DPRK listed items that could contribute to DPRK's nuclear-, ballistic missile-, and other weapons of mass destruction-related programmes
- Supply of luxury goods to DPRK







#### All arms and related materiel







- Resolution 1874 has expanded the scope of the arms <u>embargo</u> with regard to the Democratic People's Republic of Korea to include <u>all arms and related materiel.</u>
- However, it makes an <u>exception for small arms and light</u> <u>weapons and their related materiel</u> as far as their supply to the Democratic People's Republic of Korea is concerned.
- The resolution calls upon Member States to <u>exercise</u>
   <u>vigilance</u> over the supply of such items to the Democratic
   People's Republic of Korea and directs that they notify the
   Committee when they supply such items to the Democratic
   People's Republic of Korea.

  - INFCIRC/254/Rev.8/Part 2. (30 June 2010)

- WMD (Chemical and biological programmes) -related items
  - S/2006/853\* and S/2006/853/Corr.1 (identical with the Australia Group list as of 13 October 2006)

# Additional information about the nuclearrelated items

- IAEA confirmed that the DPRK had attempted to procure from a wide range of supply chains material and equipment required for uranium enrichment, such as vacuum pumps, electronic equipment and dual-use, computer numerically controlled, machine tools.
- Independent experts however have indicated the possibility that the DPRK could use <u>materials of lower parameters than those</u> <u>specified by the lists of designations in the resolutions for its nuclear programmes</u>, though at an operational cost.23

# Additional notes on several paragraphs of UNSCR 2087 (2013)

- In paragraph 10, the Security Council calls upon Member States which have not yet done so to report on the measures they have taken to implement the provisions of resolutions 1718 (2006) and 1874 (2009), and encourages other Member States to submit, if any, additional information on implementing the provisions of resolutions 1718 (2006) and 1874 (2009).
  - Please submit national reports pursuant to resolutions 1718 (2006) and 1874 (2009) if you have not done so yet!!

- Recalls paragraph 18 of resolution 1874 (2009), and calls upon Member States to exercise enhanced vigilance in this regard, including monitoring the activities of their nationals, persons in their territories, financial institutions, and other entities organized under their laws (including branches abroad) with or on behalf of financial institutions in the DPRK, or of those that act on behalf or at the direction of DPRK financial institutions, including their branches, representatives, agents and subsidiaries abroad (emphasis added).
- Paragraph 18 of resolution 1874 (2009). Calls upon Member States...to
   prevent the provision of financial services or the transfer to, through, or
   from their territory, or to or by their nationals or entities organized under
   their laws (including branches abroad), or persons or financial institutions
   in their territory, of any financial or other assets or resources that could
   contribute to the DPRK's nuclear-related, ballistic missile-related, or other
   weapons of mass destruction-related programs or activities... (emphasis
   added).

- Recalls paragraph 14 of resolution 1874 (2009), recalls
  further that States may seize and dispose of items consistent
  with the provisions of resolutions 1718 (2006), 1874 (2009)
  and this resolution, and further clarifies that methods for
  States to dispose include, but are not limited to, destruction,
  rendering inoperable, storage or transferring to another
  State other than the originating or destination States for
  disposal (emphasis added).
- Paragraph 14 of resolution 1874 (2009). *Decides* to authorize all Member States to, and that all Member States shall, seize and dispose of items the supply, sale, transfer, or export of which is prohibited by resolution 1718 and 1874. this paragraph *decides* further that all States shall cooperate in such efforts.

- Clarifies that the measures imposed in resolutions 1718 (2006) and 1874 (2009) prohibit the transfer of any items if a State relevant to a transaction has information that provides reasonable grounds to believe that a designated individual or entity is the originator, intended recipient or facilitator of the item's transfer (emphasis added).
- ✓ Transfer of "any items" involving the designated individual or entity is prohibited, including those brokered by such individual or entity.

- Deplores the violations of the measures imposed in resolution 1718 (2006) and 1874 (2009), including the use of bulk cash to evade sanctions, underscores its concern over the supply, sale or transfer to or from the DPRK or through States' territories of any item that could contribute to activities prohibited by resolutions 1718 (2006) or 1874 (2009) and the importance of appropriate action by States in this regard, calls on States to exercise vigilance and restraint regarding the entry into or transit through their territories of individuals working on behalf or at the direction of a designated individual or entity, directs the Committee to review reported violations and take action as appropriate, including through designating entities and individuals that have assisted the evasion of sanctions or in violating the provisions of resolutions 1718 (2006) and 1874 (2009) (emphasis added).
- Use of bulk cash to evade sanctions is prohibited clearly.
- Exercise vigilance and restraint relating to travel by individuals working on behalf of or at the direction of designated individual or entity.
- Entities and individuals that have assisted the evasion of sanctions or in violating the provisions of resolutions can become the subject of designation.

*Emphasizes* the importance of all States, including the DPRK, taking the necessary measures to ensure that no claim shall lie at the instance of the DPRK, or of any person or entity in the DPRK, or of persons or entities designated pursuant to resolutions 1718 (2006) and 1874 (2009), or any person claiming through or for the benefit of any such person or entity, in connection with any contract or other transaction where its performance was prevented by reason of the measures imposed by resolutions 1718 (2006) and 1874 (2009) (emphasis added).

## Paragraphs 17 and 18

- 17. Reemphasizes that all Member States should comply with the provisions of paragraphs 8 (a) (iii) and 8(d) of resolution 1718 (2006) without prejudice to the activities of the diplomatic missions in the DPRK pursuant to the Vienna Convention on Diplomatic Relations.
- 18. Underlines that measures imposed by resolutions 1718 (2006) and 1874 (2009) are not intended to have adverse humanitarian consequences for the civilian population of the DPRK;
