### U.S. Arms Exports



#### Foreign Military Sales (FMS)

- Government to Government transfers subject to approval by Department of State; administered by Department of Defense
- Subject to Arms Export Control Act (AECA) and Foreign Assistance Act (FAA)

#### Direct Commercial Sales (DCS)

- Commercial arms sales subject to export authorization by Department of State
- Subject to AECA and International Traffic in Arms Regulations (ITAR)

#### Dual-use

- Commercial sales of dual-use items subject to control by Department of Commerce
- Subject to Export Administration Act (EAA) and Export Administration Regulations (EAR)



## Legal Authorities



Reference	Subject
AECA (Arms Export Control Act), Sections 3(g), 38(g)(7), and 40A	Establishes DDTC and legal authority for defense trade controls; requires end-use monitoring of defense articles and services
ITAR (International Traffic in Arms Regulations)	Implementing regulations for AECA, specifies the United States Munitions List (USML)
FAA (Foreign Assistance Act), Sec 505 FAA, Sec 515(a) FAA, Sec 623	Permits observation of use of articles, services, and training
	Overseas management of assistance and sales programs Requires supervision of end-use of FAA grant items
EAR (Export Administration Regulations)	Regulate the export and re-export of most commercial items, specifies the Commerce Control List (CCL) of dualuse items



## Legal Authority



- Arms Export Control Act (AECA)
  - Section 38 of the Arms Export Control Act (22 U.S.C. 2778) authorizes the President to control the export and import of defense articles and defense services.
    - Authority delegated to the Secretary of State by Executive Order 11958, as amended.



## International Traffic in Arms Regulations (ITAR)




Implementing regulations of the AECA (22 CFR Parts 120-130)

- Part 121 contains the U.S. Munitions List (USML)
  - 21 USML Categories classifying all defense articles under ITAR jurisdiction.
- Also includes regulations on: registration, licensing, licensing exemptions, agreements, brokering activity, proscribed destinations (embargoed states), violations and penalties, and reporting of political fees and contributions.

# Directorate of Defense Trade Controls



- **DDTC Mission**: Advance U.S. national security and foreign policy interests through licensing of defense articles, and the development and enforcement of export control laws, regulations, and policies.
  - Registration of manufacturers and exporters
  - License reviews and issuance
  - End-use monitoring
  - Enforcing ITAR and AECA compliance
  - Issuance of guidance to exporters, foreign partners
  - Managing and revising regulations

### **Export Control Reform**



In August 2009, President Obama directed U.S. export control
agencies to conduct a broad-based review of export controls to
identify additional ways to enhance U.S. national security.

"While there is still more work to be done, taken together, these reforms will focus our resources on the threats that matter most, and help us work more effectively with our allies in the field. They'll bring transparency and coherence to a field of regulation which has long been lacking both. And by enhancing the competitiveness of our manufacturing and technology sectors, they'll help us not just increase exports and create jobs, but strengthen our national security as well."

### New ECR Concepts



- Identifying the specific items on a more positive USML that warrant individual license reviews
  - "Higher walls around fewer, more critical items"
- Amending the EAR and CCL to control former USML items so they are still controlled as military items, but in a more flexible way
  - Items removed from the USML are <u>not</u> "decontrolled" but export control is moved to the Department of Commerce under the new "600 series" or other export control classification number (ECCN)
  - Paragraph X: licensing of items subject to the Department of Commerce's jurisdiction
  - Order of Review: specifies how to apply the ITAR and EAR
  - Specially designed: control based on design intent and use



### USML: Old vs. New



Current USML Category VIII(h) – "catch all":

"Components, parts, accessories, attachments, and associated equipment (including ground support equipment) specifically designed or modified for the articles in paragraph (a) through (d) of this category, excluding aircraft tires and propellers used with reciprocating engines."

• Sample Revised USML Category VIII(h) – "positive control criteria":

"(h)(8) Threat-adaptive autonomous flight control systems;"

"(h)(13) Lithium-ion batteries that provide greater than 28 VDC nominal;"

"(h)(23) Fuel cells specially designed for aircraft controlled in this category or controlled in ECCN 9A610;"



## ECR Implementation (What's Next?)



- 2015 Priorities
  - USML: 15 of 21 USML Categories revised and effective by end of 2014
  - Remaining USML categories under interagency review
  - Definitions: Review under way
    - 120.9 Defense Services
    - 120.10 Technical Data
    - 120.11 Public Domain
    - 120.17 Export (including intangible/electronic)
  - Annual review of revised USML (beginning with Categories VIII and XIX)
- Increased harmonization, common IT infrastructure, dynamic process
