


# 1. Change in Environment Surrounding Academia



#### **Japanese Universities**




#### Faculty (total 180,879)


#### **Internationalization of Academia**


**Key Points of Promotion Activities**

# **3. Encouraging Security Trade Controls**



### (1) Requests from Government to Academia

(1) "Enhancing Export Control at Academia" released by Director-General, Trade and Economic Cooperation Bureau, METI (2005)

(2) "Enhancing Export Control at Academia" released by METI Minister, and informed to Academia by MEXT(2006)

(3) "Compliance Requirements for Exporters" introduced in 2009 and enforced in April, 2010

(4) "Enhancing Export Control at Academia" released by Director-General, Trade and Economic Cooperation Bureau, METI, and informed to Academia by MEXT (2009) (1) Holding seminars in all 47 prefectures.(2006-2009)

(2) Holding seminars in 8 blocks across Japan. (2010-2012)

(3) Inviting lecturers from Academia to share good practices. (2013-)

# 4. Lessons from Some Universities' Actions



### **Key Points from Some Actual Actions**

- To bridge laboratory office and trade control office within university.
- To conduct surveys of experiment equipment and materials in all laboratories.
- To make flow chart and check lists for listed goods/technologies (including acceptance of international students and researchers).
- To introduce risk-based approaches or simplified procedures for low risk goods/technologies.
- To introduce PDCA cycle for continuous improvement including internal audit.
