

# About ATAS – what is it?

- ➤ Government-run student vetting scheme set up in 2007 to address transfers of sensitive knowledge through postgraduate study
- ➤ Requires students offered a place on certain sensitive taught or research courses to obtain UK government clearance
- ➤ ATAS targets knowledge that may help develop or use WMD and their means of delivery: **nuclear**, **chemical**, **biological**, **radiological**, **toxin** programmes, also **ballistic missile**.



# Why do we have it?

- ➤ Meets UK objectives to deny states WMD capabilities and means of delivery, reducing risks of associated instability
- ➤ Delivers international commitments, e.g. Nuclear Non-Proliferation Treaty (NPT), relevant UNSCRs, commitments under Export Control Regimes
- Cases in past of postgraduate foreign students becoming weapons proliferators





## How does it work?

- ➤ Students present evidence of ATAS clearance to UK Visas & Immigration when applying for a visa
- > Required by UK immigration legislation, where sensitive courses are listed
- ➤ Applies to postgraduate students from most countries (not European Economic Area /Switzerland)





# How does it work contd...?

Student submits electronic application to UK government



Application vetted



Decision made to approve/deny ATAS Clearance



Decision emailed as certificate to student / academic institution




Student applies for visa or makes new/amended application



# Outreach

- > Scheme is heavily subscribed: over 20,000 applications in 2014
- > Importance of foreign students to UK universities: effective outreach needed
- ➤ Outreach is dual purpose:
  - improves **compliance** with ATAS requirements
  - improves **service** levels and expectations





# Compliance



### Clarity of requirements:

➤ Universities told which courses of interest and which levels via ATAS website and immigration rules

### Enforcement angle:

- ➤ Universities that fail to comply put at risk prized immigration sponsor status
- > Students warned on certificate that fraud punishable by criminal penalties





# Compliance contd...

### Other key elements:

- ➤ Unique number generated for document security (recent student fraud uncovered this way)
- ➤ Universities required to request ATAS clearance when course is changed, extended or relocated
- Institutions advised to inform UK government when offering courses overseas (export licensing)



# Service



## Reputational angle:

- Must be light touch and not undue barrier to academic exchange
- ➤ International relations: important to ensure timely decisions and be clear on rationale for denials

## Economic angle:

> Importance of international students to universities and UK economy



# Service contd....

### Elements to efficiency of scheme:

- ➤ Need credible timeframe for vetting (20 working days)
- ➤ Over 85% of applications successfully processed within this timeframe
- ➤ Managing expectations through regular contact with universities, including hotline, mailbox, visits

### Review option:

> Students can appeal; involves actors not party to original decision







# Conclusion

Key factors for running an effective scheme that balances security and economic considerations:

- ➤ Clear criteria for submitting and completing applications
- ➤ Keep to service targets that are clearly communicated
- > Fully utilise communication channels to meet and manage expectations
