## The DPRK sanctions regime: prohibited goods

	↔	WMD related-items (as listed) and associated specialized teaching, training, advice, services or assistance	1718 2321
	↔	All arms and related materiel and associated training, advice, services or assistance, dual use conventional arms list	1718, 1874 2270 2321
	→	Luxury goods	1718 2321
	→	Any item which could contribute to the DPRK WMD programs, prohibited activities, armed forces or arms exports (catch-all provision)	2270
	→	Aviation fuel	2270
	←	Coal, iron, iron ore (with exemptions); gold, titanium ore, vanadium ore, rare earth minerals; coal "cap", copper, nickel, zinc;	2270 2321



## The DPRK sanctions regime: transport



Prohibit their nationals and entities from registering vessels in the DPRK, obtaining authorization for a vessel to use the DPRK flag

UNSCR 2270 and 2321 (2016)



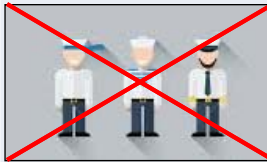
Prohibited from owning, leasing, operating, any classification, certification or associated services

UNSCR 2270 and 2321 (2016)



Prohibited from providing insurance or re-insurance services for any vessel flagged, owned, controlled or operated by the DPRK

UNSCR 2321 (2016)



Prohibited from procuring DPRK crews for aircraft or vessels

## The DPRK sanctions regime: inspect!



**Inspect cargo to/from DPRK** (directly or indirectly or brokered by the DPRK ),  
**transiting or within state's territory**, including airports, seaports and free trade zones,  
**or transported on DPRK flagged vessels or aircraft;**

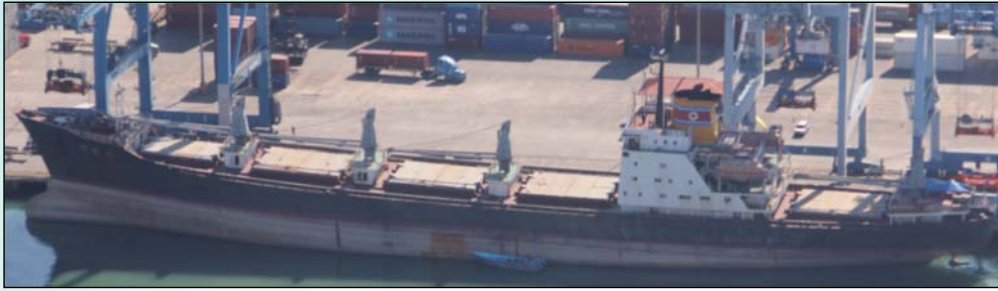
**!! Also personal luggage & checked baggage**

## The DPRK sanctions regime: vessels



- **Under certain conditions\*, inspect vessels on the high seas and in their territory.**

**UNSCR 1874 (2009)**

[\* Reasonable grounds & consent from flag state]

- **Prohibit vessels that refuse inspection and designated vessels from entering port.**

**UNSCR 2094 (2013) and 2321 (2016)**

- **Prohibit provision of bunkering services to DPRK vessels if suspected of carrying prohibited cargo.**

**UNSCR 1874 (2009)**



## The DPRK sanctions regime: transport

**DPRK may not purchase:**

- **New helicopters or vessels**
- **Aviation fuel**
- **Truck chassis with six or more axles**
- ***Commercial vehicles & equipment for military use\****

**UNSCR 2321 (2016)**



\* Considered "arms and related materiel"
